RE: U visas and armed robberies

Dear Major Anderson:

I appreciate that Raleigh Police Department is looking into this issue. As previously discussed, I am respectfully requesting that Raleigh Police Department begins certifying armed robberies as "false imprisonments" for two reasons: first, North Carolina law actually supports the notion that all armed robberies constitute false imprisonments; and second, USCIS is granting U visas based on armed robbery.

To qualify for U-1 nonimmigrant classification, a petitioner must establish that he or she has suffered substantial physical or mental abuse as a result of having been the victim of qualifying criminal activity; possesses information concerning the qualifying criminal activity; and has been helpful, is being helpful, or is likely to be helpful to law enforcement authorities investigating or prosecuting the qualifying criminal activity. Section 101(a)(15)(U)(i) of the Act.

A "victim of qualifying criminal activity" is defined as an individual who has "suffered direct and proximate harm as a result of the commission of qualifying criminal activity." 8 C.F.R. § 214.14(a)(14). "Qualifying criminal activity" is "that involving one or more of the 28 types of crimes listed at section 10l(a)(15)(U)(iii) of the Act or "any similar activity in violation of Federal, State, or local criminal law." Section 101(a)(15)(U)(iii) of the Act; 8 C.F.R. § 214.14(a)(9).

The statutory list of qualifying criminal activity in section 101(a)(15)(U)(iii) of the INA, 8 U.S.C. 1101(a)(15)(U)(iii), is not a list of specific statutory violations, but instead a list of general categories of criminal activity. It is also a non-exclusive list. Any similar activity to the activities listed may be a qualifying criminal activity.

New Classifications of Victims of Criminal Activity, Eligibility for "U" NonImmigrant Status, 72 Fed. Reg. 53,014, 53,018 (Sept. 17, 2007) (to be codified at 8 C.F.R. pts. 103, 212, 214, 248, 274a & 299 (emphasis added) (the "Interim Rule").

There is no statute in North Carolina making false imprisonment a crime, but it was a crime at common law, and the common law was adopted as the law of this State. N.C. Gen. Stat. § 4-1. False imprisonment is the illegal restraint of someone against their will. State v. Dix, 282 N. C. 490, 193 S. E. 2d 897 (1973). Armed robbery cannot be committed without some restraint of the victim. State v. Fulcher, 294 N.C. 503 (1978). Restraint is an inherent, inevitable feature of armed robbery. Id.; see also State v. Prevette, 317 N.C. 148, 157 (N.C. 1986) ("We recognize the fact that murder is not within that class of felonies, such as forcible rape and armed robbery, which cannot be committed without some restraint of the victim"); State v. Pigott, 331 N.C. 199, 210 (1992) ("We hold that all the restraint necessary and inherent to the armed robbery was exercised by threatening the victim with the gun.")

A "technical assault" is "always necessarily included in any robbery" <u>People v. Dozier</u>, 90 Cal.App.3d 174, 178 (Cal. Ct. App. 1979) (cited for persuasiveness) and a "technical assault is always committed with false imprisonment[.]" <u>Fowler v. Valencourt</u>, 334 N.C. 345, 348 (1993). For those reasons, even if the perpetrator is only charged with armed robbery, the cooperating victim remains eligible for a U visa based on the substantially similar offense of false imprisonment. See 8 C.F.R. 214.14(a)(9) ("The term 'any similar activity' refers to criminal offenses in which the nature and elements of the offenses are substantially similar to the statutorily enumerated list of criminal activities.")

Also, notwithstanding the literal language of the regulations, USCIS systematically grants U visas to victims of robbery. According to a USCIS FOIA release, in 2016, USCIS granted 130 U visas based on the crime of "Robbery". To the extent that Raleigh Police Department believes that the law on U visas and armed robberies is grey, it would be the best practice to nonetheless sign the otherwise eligible certifications and allow this issue to be elucidated by federal tribunals.
